Governor Shapiro, Lieutenant Governor Davis, Speaker McClinton and Majority Leader Bradford,

On behalf of the undersigned organizations, who represent hundreds of thousands of Pennsylvanians, we support HB 652 and look to you for your leadership in helping it gain greater traction among Democratic legislators and ensuring its successful advancement through the legislature.

HB 652 would uplift Environmental Justice (EJ) communities and is modeled on successful policies adopted in New Jersey, Minnesota and most recently Massachusetts. It requires certain known polluting facilities seeking permits to build or expand in EJ communities to prepare a cumulative environmental assessment that includes potential negative impacts their operations may have on the broader area they're operating in and empowers the Pennsylvania Department of Environmental Protection (DEP) to deny a permit application or require added stipulations for approval if it finds those impacts would further harm the health and environment of the community.

HB 652 is also the perfect complement to the recent revisions DEP made to their Environmental Justice Public Participation Policy which improved the previous iteration of the PennEnviroScreen, enhanced opportunities for community participation in the permitting process, and prioritized inspection and monitoring for certain sites within EJ communities. Yet at the DEP's own admission the policy is not without its limitations because according to Fernando Treviño, Special Deputy Secretary for Environmental Justice, "DEP is limited in its ability to enact regulations because the department isn't a legislative body. In order to make it enforceable with rules, it's up to the legislature to pass bills that will make some of this stuff mandatory." HB 652 is the best vehicle to create the needed additional statutory authority DEP is referencing and advocating for.

Roughly 2.3 million people live in 1,965 identified EJ areas according to the update PennEnviro Screen tool which uses 32 determination indicators, including exposure to pollution and toxic emissions, traffic volume, and proximity to oil and gas wells. It also considers race, age, income, graduation rates, unemployment, and health conditions like asthma and cancer. Historically, these areas have been forced to bear a disproportionate share of adverse environmental impacts. These conditions result in poor health as well as the creation of undesirable living conditions that prevent communities from growing and truly flourishing.

HB 652 has already been co-sponsored by half the House Democratic delegation. We truly appreciate you also being among its supporters but more is needed. Controlling both the Governor's Mansion and Pennsylvania House of Representatives for the first time in over a decade represents an opportunity to finally move proactively toward creating meaningful avenues that assure the fair treatment of all people, regardless of race, color, national origin, or income, with respect to the development, implementation, and enforcement of environmental laws, regulations, and policies. Please further partner with us to help pass HB 652.
